ANNUAL BUSINESS MEETING  
June 8, 2023**

The minutes of the Iowa Water Environment Association Annual Business Meeting, held at Waterloo Convention Center in Waterloo on June 8, 2023.

**ITEM I: CALL TO ORDER**

The meeting was called to order by President-elect Curt Kampman at 12:34 PM.
